**PENSION REFORM** 

EXECUTIVE ON TUESDAY FEBRUARY 19, THE NCCMP RELEASED A REPORT ENTITLED SUMMARY: SOLUTIONS NOT BAILOUTS: A COMPREHENSIVE PLAN FROM BUSINESS AND LABOR TO SAFEGUARD MULTIEMPLOYER RETIREMENT SECURITY, PROTECT TAXPAYERS, AND SPUR ECONOMIC GROWTH.

IN AUGUST OF 2011, THE NCCMP CONVENED A BROAD CROSS SECTION OF THE MULTIEMPLOYER COMMUNITY TO STUDY THE CHALLENGES FACING MULTIEMPLOYER PENSION PLANS AND DEVELOP A PROPOSAL FOR REFORM. KNOWN AS THE "RETIREMENT SECURITY REVIEW COMMISSION" THE GROUP INCLUDED REPRESENTATIVES FROM OVER 40 ORGANIZATIONS, EVENLY SPLIT BETWEEN BOTH SIDES OF THE BARGAINING TABLE, AND SPANNING NEARLY EVERY INDUSTRY WITH SUBSTANTIAL MULTIEMPLOYER PLAN PARTICIPATION. TODAY'S REPORT DETAILS THE FINDINGS AND RECOMMENDATIONS OF THIS COMMISSION, INCLUDING A COMPREHENSIVE PROPOSAL FOR REFORM.
