Our Lawyers and Administrators Meeting brings together technical experts and plan professionals on both multiemployer health and pension plan topics to discuss current areas of concern. Attendees participate in forums with representatives from the government agencies with jurisdiction over multiemployer plans. These forums foster open dialogue between the multiemployer community and agency representatives on issues facing multiemployer plans.

We will feature discussions with government officials in the morning and presentations from technical specialists in the afternoon, while preserving time for discussion of issues important to you, but which may not be addressed in the formal agenda.

Meeting materials will be available at our website, and wifi service will be available to access materials during the meeting.

As in past years, we have invited speakers from the Treasury, PBGC, DOL, IRS, and HHS to discuss their regulatory priorities and expectations for the coming year.

### *This year's preliminary agenda has the following highlights:*

- An update on the current funded status of the PBGC, including the latest deficit projections, and estimated insolvency
- An in-depth discussion of Federal Credit, and the implications for any multiemployer loan program
- A status report on outstanding and approved rescue applications filed under MPRA, including experiences of recent approvals
- An update on GROW Act legislation to authorize creation of GROW (composite) Plans
- An update on current issues in healthcare reform
- An early stages report on the Joint Select Committee on Solvency of Multiemployer Pensions
