Mental health situation in Europe

The **"Health at a Glance Europe 2018 report"** highlighted that mental health problems affect about **84 million people** across the EU. Moreover, the total costs of mental health problems are estimated to amount to more than 4% of GDP across EU countries, equivalent to over €600 billion per year.

COVID-19 pandemic, unemployment and rising living costs, the pressures of the digital sphere and social media, the climate crisis and war in Ukraine have exacerbated the already poor levels of mental health, especially for children and young people in EU. During the pandemic, people in the EU affected by loneliness doubled compared to pre-pandemic years, reaching 26 %.

The **"Health at a Glance Europe 2022 report"** showed that almost one in two young Europeans report unmet needs for mental health care, and the share of young people reporting symptoms of depression in several EU countries more than doubled during the pandemic.

Address vulnerable groups by providing targeted support to those most in need

 A special focus includes conflict-affected populations, notably people (in particular children) displaced from Ukraine and children in Ukraine subject to the trauma of war.

 Raising awareness and providing quality mental health support in humanitarian emergencies.
